REGULAR MEETING OF THE WEST SACRAMENTO AREA FLOOD CONTROL AGENCY April 20, 2023 Minutes

The meeting was called to order at 9:39 AM by Chair Tom Ramos. Vice Chair Alcala and Director Sulpizio Hull were present. Chair Ramos presided. Also in attendance were General Manager Greg Fabun, clerk Katie Dyck, staff members Paul Dirksen and Mark Zollo, and Agency General Counsel Ralph Nevis.

Entry No. 1

Heard General Administration Functions as follows:

- B. Report out on Closed Session

Ralph Nevis reported that the Board met in Closed Session with legal counsel regarding the two items listed on the Closed Session Agenda. No reportable action was taken on any items.

C. Monthly/YTD revenue and expenses

Mark Zollo reported on the monthly revenue and expenses for February 2023. Fund 870's starting balance was approximately \$6.8M. There was no revenue. Expenditures were \$6k, leaving the ending balance at \$6.8M. Fund 871's starting balance was approximately \$5M. There was no revenue. Expenditures totaled \$345k. The ending balance for fund 871 was \$4.7M. The Agency's combined cash position (funds 870, 871, and 257) for the month was \$11.4M.

As of 4/12/23, the Agency's combined cash position was approximately \$10.7M.

This week, the Agency received a true up payment of \$1.5M Qtrs 44-46 from the State bringing the total cash position up to approximately \$12M. Staff is currently working on a construction retention release for \$306k and final real estate payment for \$2.8M. Afterwards, staff will work with DWR to determine the remaining amount in the Construction Funding Agreement and hope to get that advanced to the Agency for work-in-kind toward the Federal Project.
